#### **2022 Market Observations**

I'm reminded of the Chinese curse - 'may he live in interesting times...'

- War in Ukraine
  - Energy prices up 50% or more
  - Food shock will last years, wheat prices up 40% (World bank)
  - Non-energy commodity prices up 20% (World bank)
  - Cyber attacks
- Covid-19 Pandemic
  - Switch to e-commerce more strain on warehouse space
  - Port congestion ships idling 30+ days
  - China US taking 74 days longer than normal (Reuters)
  - Shanghai Covid Lockdown factories, port workers
- Ships continue to get stuck / lose containers
  - Ever Forward 12,118 TEU containership grounded March 13, finally refloated April 17 after removing 500 containers.
  - Felicity Ace caught fire and sank with 4,000 autos on board
- Nat Cat cost global economy \$32 Billion in Q1 (Aon)
  - Vancouver floods
  - Higher than average hurricane season forecast for 2022











#### **2022 Market Observations**


Supply chains increasingly stretched and disrupted.

Bloomberg reduce 2022 forecasted global GDP by \$1.6 Trillion


Sanctions impact – e.g. no more Russian oil or gas

Inflation at 40-year high

Secretary General of the UN – Antonio Guterres: "There is enough food in our World now if we act together, but unless we solve this problem (Ukraine unable to export wheat, grains and cooking oil) we face the spectre of global food shortage in the coming months"
